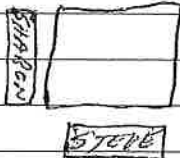

I AM INFORMALLY ATTEMPTING TO RESOLVE ONGOING FIRST AMENDMENT RETALIATION BY COITZ J. OSTRANDER, #11433 FOR VIOLATING THE GRIEVANCE SYSTEM AS FOLLOWS; (A VIOLATION OF 802.10.1.1.)

ON 9-2-17 COITZ OSTRANDER WROTE A FALSE DISCIPLINARY REPORT AGAINST ME AFTER I ASKED HER IF SHE HAS A PERSONAL VANDETTA AGAINST ME. FOLLOWING MY VISIT, I SPoke WITH OSTRANDER ABOUT HER ON GOING HARASSMENT OF MY VISITOR, [REDACTED], AND I. THE VERBAL COMMUNICATION WITH OSTRANDER WAS MY FIRST STEP IN THE GRIEVANCE PROCESS (D.D. 802.02.1.). FOLLOWING THIS STEP, SHE WROTE A FALSE DISCIPLINARY TICKET, AIT-AY-DTOS, ALLEGING A VIOLATION OF "PUBLISHED" RULES FOR MY "LET'S TALK" BEING PRESSED AGAINST [REDACTED] "RIGHT TALK." THIS IS IMPOSSIBLE AS WE SAT AT DIFFERENT SIDES OF A TABLE AS SHOWN BELOW:



FURTHER, NO "PUBLISHED" RULE WAS VIOLATED PREMISED ON HER DESCRIPTION OF EVENTS. ON 9-2-17 AN E-MAIL WAS SENT TO CRYAN TO PRESERVE CAMERA DATA, REVIEW OF THIS FOOTAGE WILL SUPPORT ANY "TALK" CONTACT WAS IMPOSSIBLE. OSTRANDER'S TICKET PROVES SHE WROTE HER FALSE TICKET AFTER I INITIATED VERBAL RESOLUTION OF THIS ISSUE. HER INDIVIDUAL OR COLLECTIVE BEHAVIOR IS RETALIATION DUE TO A PREVIOUS REQUEST OF AN INVESTIGATION AT VISITATION STAFF AND A PRIOR GRIEVANCE OF AN IMPROPER VISITATION SUSPENSION. REGARDLESS OF ADMINISTRATIVE DISPOSITION OF THIS TICKET, CAMERA EVIDENCE WILL ULTIMATELY PROVE OSTRANDER HAS FILED A FALSE REPORT. FURTHER, IF CAMERA FOOTAGE IS LOST, IT WILL LOOK EVEN WORSE ONCE THIS REACHES A COURT OF LAW. AND, COITZ OSTRANDER HAS VERNALLY ADMITTED TO [REDACTED] THAT SHE WROTE THE DISCIPLINARY TICKET BECAUSE I QUESTIONED HER POLICY SIGNATURE.
